FSSAI Food License Registration in India

What is FSSAI Registration?

- The Food Safety and Standards Authority of India (FSSAI) is a legal authority that offers a food license to all food business operators (FBO) in India.
- FSSAI Registration ensures the security of food products and it is essentially a food safety certificate circulated by the food authority in India.

Need for FSSAI Registration

- FSSAI has been created for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import to ensure availability of safe and wholesome food for human consumption.

FSSAI license vs FSSAI registration

- Any person or entity that does not classify as a petty food business operator is required to obtain an FSSAI license for operating a food business in India.
- The fee and procedure for obtaining an FSSAI license are more extensive when compared to an FSSAI registration.

Is FSSAI license Mandatory?

- Obtaining an FSSAI license is mandatory before starting any food business operation in India.
- As per the Food Safety and Standards Authority of India (FSSAI) rules, it is mandatory for food-related businesses, however small, to apply for a license or registration.

Who all need FSSAI License?

- All the traders, manufacturers, restaurants who are involved in the food business must obtain a 14-digit license number which is printed on their food products.
- It is mandatory to acquire FSSAI registration for traders or all food business operators who are involved in the food business.
- Eligible Food Business Operators like manufacturers, storage, transporters, retailers, marketers, distributors, etc. need to take a License from the State Authority.

Does one need FSSAI License for selling Homemade Food?

- Yes, you need a food license from FSSAI to sell homemade food but if it is a small scale, only registration is required.
- Homemade food or Hotel food each and every Food Business Operator (FBO) is required to either register or get a Food License.

Does one need FSSAI License for selling food on Online food websites like Swiggy and Zomato?

- You need an FSSAI License to run an Aggregator Food Delivery apps like Swiggy, Zomato, Uber eats, Foodpanda, etc as they are e-commerce entities giving listing, directory of FBO, food products and also facilitating orders or transaction on their website.
- FSSAI License is mandatory for all the restaurants.

Categories of FSSAI/ Food License

There are three Categories of FSSAI/ Food License, depending upon the turnover of the Food Business Operator.

- FSSAI Basic License.
- FSSAI State License.
- FSSAI Central License.

Documents required for FSSAI registration

- Photo of Food Business Operator.
- Document for Identity Proof like Ration Card, Voter ID Card, PAN Card, Driving License, Passport, Aadhar Card, Senior Citizen Card, Department Issued ID.
- Supporting Documents (if any):- NOC by Municipality or Panchayat, Health NOC.

Time it take to get FSSAI license

- A license has to be issued by the Licensing Authority within 60 days of making complete application by an applicant.
- This time includes scrutinization of application and inspection of premises by the concerned authority.

Penalty of operating a food business without an FSSAI License

- If a food business operator operates a food establishment without acquiring an FSSAI license, the act is punishable under law.
- The food business operator may face **imprisonment** and FSSAI license penalty up to rupees 5 lakhs for the same.

- The FSSAI License application is an extensive process subject to strict adherence to complete and accurate paperwork and procedure. An error in paperwork is likely to delay the process by several weeks or even months leading to loss of time and money.
