

How to Apply for UL VNO ISP license?

Why go for a UL VNO ISP License?

If you want to start your ISP business in fewer budgets then you can go for UL VNO ISP!

Who all can apply for UL VNO ISP license?

Only those firms which are registered according to companies act are eligible for applying the UL VNO ISP license that is company should be a Private Limited firm and when you make a company as a Private Limited firm then there is the document named as MOA (Memorandum Of Association), in this document you have to mention that what type of services Or what type of business you will do in that company so in that it should be mentioned that you will act as an Internet Service Provider or you will provide Internet Services then only you are eligible for applying for UL VNO ISP license . Which is a mandatory requirement.

What are the Three types of UL VNO ISP licenses?

You have to decide that what level of ISP business you want to do according to the DoT there are three types of UL VNO ISP license based on their area, these areas are categorized by DoT.

- **Category A** which is for All India or National level that means in this category you can work All over India anywhere in India as ISP.
- **Category B** , in this can work as ISP in Telecom Service Area or Metro area broadly defined it can be a state level or four metros.
- **Category C** is small level which is term as Secondary Switching Area (SSA) which is the smallest area where you can work an ISP.

After finalizing the category then you have you have to prepare documents (for details for documents you can call us) based on your category , you have to submit these documents online on a government portal. The payment like an application fee and entry fee will be done online through a Bharatkosh website

How much times does it take to get a UL VNO ISP license?

After submission of application online then you have to wait for two and a half to three months for application processing, DoT take two and a half to 3 months defaults for an application processing. After processing application Dot releases a letter which is termed as Letter of Intent (LOI), after receiving this letter government gives 60 working days for preparation of Bank guarantees and submission of entry fee. After submission DoT will verify these bank guarantees and entry fee then they will send invitation for the signing license
