VNO ISP License Requirements

- Only those firms which are registered according to companies act are eligible for applying the UL VNO ISP license that is the company should be a Private Limited firm and when you make a company as a Private Limited firm then there is the document named as MOA (Memorandum Of Association), in this...

VNO ISP License Requirements

- ...document you have to mention that what type of services Or what type of business you will do in that company so in that it should be mentioned that you will act as an Internet Service Provider or you will provide Internet Services then only you are eligible for applying for UL VNO ISP license and that is the mandatory requirement.

VNO license Registration Process

- It is an elaborate process where you have to produce documents and fulfill the required criteria. Once you submit your documents with the authorities, it goes for verification and validation and takes a couple of weeks at each phase. The license takes a few months before approval if all is done properly as per the defined process.
- **However if the documentation is not proper or you miss the fine points during submission, the application will take much longer for rectification and processing further.**
