

## **VNO License Registration Process India**

Want to Apply for UL VNO ISP License? Expert Guide on VNO ISP License Registration in India – Latest updated information on UL VNO License Documents, Fees, Guidelines and Registration Process.

### What is VNO license?

- A Virtual Network Operator is an internet service reseller extending high-quality network and management services to other networking companies that do not possess their own telecom setup.
- A VNO (Virtual Network Operator) License is a miniature version of an ISP license. With an ISP license, you can run internet services on a larger domain.
- Validity for this license is 10 years.

# Why go for VNO license?

- ISPs who wish to operate small level internet service only in a particular territory can choose a VNO license instead of an ISP license. VNO is affordable, less complicated, convenient and ideal for small level ISPs.
- This license is needed for running Internet services or Data services in India. You can provide internet services like Leased Line/Broadband /VOIP /IP TV etc.
- Issuing Authority Department of Telecommunication Delhi.

#### **Categories of VNO License**

- Select the category in which you want to apply for the VNO ISP License, opt between A, B or C category. The three different categories of VNO ISP license in India are bifurcated by Dot.
- Country is divided into 24 Service Areas consisting of 20 Telecom Circle Service and 4 Metro Service Areas for Category "B" 322 Secondary Switching Areas for Category "C" VNO ISP license is cheapest for class C.

#### VNO license - 3 Categories

- UL VNO Category A: Pan India category. If you get this class of VNO License, you can provide internet access across the country.
- UL VNO Category B: Valid in 20 major states. Among all the categories, it's the VNO Access B License that is sought after the most. The VNO License B class fee is lower than that of class A. Furthermore, it provides the most venues of expansion of your business.
- UL VNO Category C: Valid in a secondary switching area. This particular VNO ISP License is suitable for small regions like a town, a district or a colony.

### **Eligibility Criteria**

 To obtain UL VNO License, your business should be incorporated as per the provisions of the Companies Act 1956

#### Mandatory Guidelines

• Only those firms which are registered according to companies act are eligible for applying the UL VNO ISP license that is the company should be a Private Limited firm and when you make a company as a Private Limited firm then there is the document named as MOA (Memorandum Of Association), in this document you have to mention that what type of services Or what type of business you will do in that company so in that it should be mentioned that you will act as an Internet Service Provider or you will provide Internet Services then only you are eligible for applying for UL VNO ISP license and that is the mandatory requirement.

#### **Documents Required**

- Certificate of incorporation of your company
- Memorandum of Association
- Articles of Association
- List of Directors
- List of shareholders
- Nature of business
- Net worth certificate
- Demand Draft or bharat kosh receipt of the UL VNO License fee

### Process of UL VNO License in India

- Fill the VNO License application form: The offline VNO License application can be downloaded from the official website. Fill it.
- Attach with the VNO License fee and wait for the response.
- Attach the required documents: The documents for the VNO License are the same as the one for ISP License.

### Process of UL VNO License in India

- Let the application be processed. The one that provides the Unified license, Telecom Regulatory Authority of India will then assess your application and provide you all the details.
- Receive the letter of intent: Upon acceptance of your application, you'll receive the letter of intent. The VNO ISP License guidelines state that you have to follow further instructions given in it.

### Process of UL VNO License in India

- Submit the bank guarantees: Further unified license fee comes in the form of bank guarantee. Submit and deliver the guarantee agreement to the DOT.
- Get the Unified License VNO: Once you've paid the remaining vno license price, you'll receive the VNO ISP License.
